



Approved Establishment of the Local Governing Body of Edgbarrow School



Proposals for the constitution of the new Local Governing Body of Edgbarrow School on joining the Corvus Learning Trust.

The Local Governing Body will consist of:

- i. 16 Co-opted Governors - appointed by the local governing body
- ii. Two parent governors – elected by ballot of parents
- iii. One staff governor – appointed after ballot of school staff
- iv. The headteacher – ex officio.
