Points to note:

Reviews of Results (RoRs):

Service 1: clerical re-check. This is a re-check of all clerical procedures leading to the issue of a result. Candidate consent is required. This service includes the following checks: that all parts of the script have been marked; the totalling of marks; the recording of marks.

Service 2: review of marking. This is a post-results review of the original marking to ensure that the agreed mark scheme has been applied correctly. **It is not a re-marking of the candidate's script.** The service is available for externally assessed components of a modular, unitised or linear specification. Candidate consent is required.

Priority Service 2: a priority review of marking is only available if a GCE A-Level candidate's place in higher education is dependent upon the outcome. Candidate consent is required.

Access to scripts (ATS):

Please note that a candidate has the right to instruct their centre not to request their scripts. Written permission must be obtained from any candidate where the centre intends to request his/her script. **This permission must be sought only after the candidates have received their results.**
